2017-75 Primary Digester Sludge Mixing/Heating tube

Motion was made by Trustee Durfee seconded by Trustee Prusak, that the Village Board approves the bid from GP Jager, Inc. for the Primary Digester Sludge Mixing/Heating tube.

2017-76 Retaining wall engineering proposal

2017-77 Notice to bid Sewage Treatment Plant Primary Digester Improvements

Motion was made by Trustee Prusak, seconded by Trustee Montford that the Village Board approves the notice to bidders for the Sewage Treatment Plant Primary Digester Improvements.

2017-78 Change order for Wet Well Pump Control Improvements

Motion was made by Trustee Durfee, seconded by Trustee Walker that the Village Board of Trustees approves the change order of \$1,500 in the Wet Well Pump Control project due to a change in the UL listing from UL508A to UL698A.

2017-79 Change parking on Exchange Street

Motion was made by Trustee Durfee, seconded by Trustee Walker that the Village Board approves the change of parking on Exchange Street. The change would consist of extending the no parking area on the west side from its current point to past the property at 110 Exchange Street. Residents in this area are having difficulties exiting driveways during AYA functions.

2017-80 Accept proposal for grant preparation

Motion was made by Trustee Montford, seconded by Trustee Walker that the Village Board approves the proposal from LaBella Associates to prepare a Consolidated Funding Application to apply for a Community Development Block Grant to fund improvements in the water system in the Village. The proposal cost is \$5,500. The improvements would include part of West Ave, Railroad and Olive Streets.

2017-81 Appointment of new Recreation Director

Motion was made by Trustee Walker, seconded by Trustee Prusak that the Village approves the appointment of Troy Colton as the new summer recreation director.

The motion was declared and carried.

2017-82 Appointment of a refuse transfer station worker

Motion was made by Trustee Montford, seconded by Trustee Durfee that the Village Board approves the appointment of Cory Buchholz as a refuse transfer station worker.

2017-82 Appointment of a part-time summer worker

Motion was made by Trustee Prusak, seconded by Trustee Walker that the Village Board approves the appointment of Tyler Meyer as a part time summer worker.

2017-83 Approval of LEXIPOL contract for the Police Department

Motion was made by Trustee Walker, seconded by Trustee Durfee that the Village Board approves the contract for LEXIPOL. This contract is for the public safety policy management program for the Attica Police Department, the cost is \$3,286 annually.

On the call of the roll, the vote was as follows: Prusak abstain; Montford yes; Durfee yes; Walker yes.

The motion was declared and carried.

Public Hearing regarding local law "Community Cats"

Motion was made by Trustee Durfee to schedule a public hearing regarding the proposed Community Cats local law. The motion was not seconded, thus the motion ends.

2017-84 Amend the local law Chapter 27 Hunting, Trapping, use of Firearms

Motion was made by Trustee Walker seconded by Trustee Durfee that the Village Board adds 27-1C "The Village Board allows the trapping of "community cats" for the purpose of a TNVR (Trap-Neuter-Vaccinate-Return) volunteer program. This local law change will only apply to live traps. This local law will expire one year after adoption, unless extended by the Village Board.

A public hearing will be set for July 18, 2017 to hear comments on this change of the local law.

On the call of the roll, the vote was as follows: Prusak no; Montford no; Durfee yes; Walker yes, Lepsch yes.

The motion was declared and carried.

Motion was made by Trustee Walker seconded by Trustee Durfee to enter into Executive session at 8:26 PM to discuss legal and personal matters.
