2025-97 Create a Gradual Transition Speed Zone on Rt. 98 Just South of Dunbar Rd to Attica Village Line.

A Resolution to Create a Gradual Transition Speed Zone on Rt. 98 Just South of Dunbar Rd. to Attica Village Line

The Town Board of the Town of Attica met at the regular Town Board Meeting at the Municipal Building, 9 Water Street Attica, NY 14011 on the 18th day of August, 2025, commencing at 7pm at which time and place the following members were:

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, 104 of the Public Officers Law, said meeting was open to the general public and due proper notice of the time and place whereof was given as required by law; and

WHEREAS, the safety and well-being of residents, pedestrians, and motorists are of the upmost importance to Town of Attica; and

WHEREAS, Rt. 98 (4,500 feet from just South of Dunbar Road to the Village Line) has been identified as an area of concern due to slow moving vehicles regularly entering and exiting; such as Municipal Trucks, Delivery Trucks, and Customers Entering or Exiting the Town of Attica Highway Department and Furniture Store; and

WHEREAS, the Town of Attica is requesting to reduce the speed from 55 mph to 45 mph to create a gradual, speed transition into the village's 30 mph zone, this will enhance safety and reduce the risk of accidents; and

WHEREAS, the Town board of the Town of Attica finds it to be in the best interest of said Town to adopt said resolution;

NOW ON MOTION OF Board Member Diehl, seconded by Board Member Wysko The Town of Attica Town Board is requesting a gradual transition speed zone on Rt. 98 just South of Dunbar Road to the Village Line from 55 mph to 45 mph to create a gradual speed transition into the Village's 30 mph zone.

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due proper notice of the time and place whereof was given as required by law; and

WHEREAS, the safety and well-being of residents, pedestrians, and motorists are of the utmost importance to the Village of Attica; and

WHEREAS, Village Code § 56-5 establishes a maximum speed limit of 30 miles per hour on all streets within the Village of Attica; and

WHEREAS, approximately 2,000 feet of High Street (Route 98) within the Village limits is still posted at 55 mph, creating inconsistency with Village Code and posing a safety hazard; and

WHEREAS, this section of High Street has been identified as an area of concern due to its winding, hilly roadway geometry, limited sight distance, and multiple residential driveways requiring vehicles to enter and exit directly into fast-moving traffic; and

WHEREAS, the Village Board of the Village of Attica finds it to be in the best interest of the Village to adopt said resolution;

BE IT RESOLVED, that the Village Board of Trustees of the Village of Attica hereby requests that the New York State Department of Transportation reduce the speed limit on the approximately 2,000-foot section of High Street (Route 98) within the Village from 55 mph to 30 mph, consistent with Village Code § 56-5;

AND BE IT FURTHER RESOLVED, that this resolution shall take effect immediately upon its adoption, and a certified copy shall be forwarded to the New York State Department of Transportation Region 4 Traffic & Safety Office, 1530 Jefferson Road, Rochester, NY 14623 for review and action.

2025-106 SEQR Resolution – Intent to Declare Lead Agency Status

Recommended Action: that the Village Board of Trustees approves that in accordance with the New York State Environmental Quality Review (SEQR) regulations, the Village Board hereby announces its intent to serve as Lead Agency to conduct an environmental review of the proposed water treatment plant project. The Village's Water Treatment Plant (WTP) operation relies upon treatment processes with insufficient capacity and non-functional or deteriorated equipment in need of replacement. The Village of Attica intends to upgrade its WTP to address deficiencies with the current treatment system, and to satisfy and maintain compliance with the National Primary Drinking Water Regulations, the Interim Enhanced Surface Water Treatment Rule, the Long Term 1 Enhanced Surface Water Treatment Rule, and the Stage 1 and Stage 2 Disinfectants and Disinfection Byproduct Rule.

FURTHER RESOLVED, the Village Board has determined that the proposed action is an Unlisted action as defined under SEQR; and, be it

FURTHER RESOLVED, the Village Board has commissioned LaBella Associates DPC to prepare Part 1 of the Environmental Assessment Form regarding the project.

FURTHER RESOLVED, the Village Board will notify the Involved Agencies of its intention to act as Lead Agency for this project and will provide them with a copy of the completed Part 1 of the Full Environmental Assessment Form for review during the 30-day comment period.
